

2019 Pennsylvania Farm Bureau Young Ag Professionals Social Media Contest Guidelines

Participation Requirements

Participants must be Farm Bureau members in good standing between the ages of 18-35. Regular and "friends of Farm Bureau" members are eligible for the contest. Only ONE video can be submitted per membership. All participants must sign a release for use of their images and/or voices used in completed videos. However, only the person(s) who submits the video will be recognized as a contest winner.

Contest Guidelines

Video entries can showcase any type of agricultural farm/facility. The subject of your film does not need			
to be your own farm/facility.			
Final video submissions cannot be longer than 5 minutes.			
The video should promote modern agricultural practices to consumer audiences of diverse backgrounds.			
All entries should be submitted on a DVD with a signed release form from the contestants and			
the landowner.			
Videos should provide an overview of the farm/facility and answer the following questions:			
1. What type of farm/facility is this?			
2. Why is this farm/facility important to know about?			
3. What makes this farm/facility unique?			
Video cannot be filmed by a professional film crew.			
Video content must be geared towards consumers of all ages.			
Videos should be education and fun to watch.			

Material Use and Ownership

All submitted videos become the property of Pennsylvania Farm Bureau and will not be returned. Participants may not use any copyrighted material.

Judging Guidelines

Quality of video	/5	Points
Quality of audio	75	Points
Creative/Entertainment	50	Points
Video Content	100	Points (Educational, Entertaining, Appropriate, Relevant Storyline (25 points each)
TOTAL	300	Points

Additional Contest Information

All submissions will be viewed by PA Farm Bureau staff prior to being judged. All submissions will be used by PA Farm Bureau to promote agriculture and may be displayed on the Farm Bureau website, You Tube, utilized at meetings, etc. The winning videos will be determined through judging by an independent panel of judges.

Prizes

Three finalists will be invited to attend dinner on Tuesday, November 19, 2019 during PFB's Annual Meeting in Hershey, PA. The winner will be announced at Tuesday evening's banquet. The overall winning applicant will receive an expense paid trip to the 2020 AFBF YF&R Conference in Louisville, KY, in addition to various other prizes.
