Looking for a few good policies

One of Farm Bureau's most important activities is policy development. Members of each county Farm Bureau submit ideas and suggestions regarding issues that affect the farming community. These ideas are written as resolutions and voted on at the county annual meeting in November. Topics cover a wide range of ag issues including wetland management, wild game, commodities, animal health, vehicles, health and safety, taxes and water quality. If an issue involves ag in any way, it can be developed for policy.

After the county meeting, voting delegates from each county attend the state annual meeting and decide by majority vote which resolutions will be adopted as Pennsylvania Farm Bureau policy. While policies are not laws, they're supported legislatively by Farm Bureau at either the state or national level.

Ideas, issues and topics can be submitted at any time of the year via anyone on the county Farm Bureau board of directors or to policy chair Sally Scholle at 717-359-9472.

Pennsylvania Records 17th Case of Highly Pathogenic Avian Influenza on June 2
A 17th case of Highly Pathogenic Avian Influenza was reported on Thursday, June 2nd, according to the U.S. Department of Agriculture (USDA) Animal and Plant Health Inspection Service (APHIS). The 17th case came from a commercial duck meat bird operation in Berks County with 30,100 birds.

As of June 2, Pennsylvania has had 4.22 million affected birds between commercial flocks in Lancaster and Berks counties and there are 349 confirmed cases in 38 states. The total number of affected birds in the U.S. is 37.5 million.

All of the affected premises have been quarantined through orders of special quarantine and all of the birds have been depopulated and composted on site. In addition, all commercial poultry facilities within a 10-kilometer (6.2 mile) radius of the infected premises became part of a "control zone" within which all poultry and associated material are subject to permitting for any movement as well as other extensive restrictions. USDA APHIS continues to maintain its publicly available HPAI 2022 Confirmed Detections database for domestic poultry and accompanying map. Nationally, Iowa leads the nation with 15 commercial flocks/premises confirmed and an additional four backyard flocks to be infected with a depopulation of more than 13 million birds. All farmers and ranchers – whether rural or urban – that grow fruit, vegetables or animals count if \$1,000 or more of such products were raised and sold, or normally would have been sold, during the Census year.

The Census of Agriculture, taken once every five years, looks at land use and ownership, operator characteristics, production practices income and expenditures for farmers.

The last day to sign up for the 2022 Ag Census is June 30, 2022. If you have never received a census and are new to NASS surveys, you can sign up online at <https://www.agcounts.usda.gov/static/get-counted.html>.

The census will be mailed out in November of this year with a response deadline of February 2023. The results of the census will be revealed in the Spring or Summer of 2024.

USDA Bay Partnership Initiative to Benefit Pennsylvania Farmers

The United State Department of Agriculture (USDA) announced last week that it will invest an additional \$22.5 million in conservation assistance in 2022 to help farmers boost water quality improvements and conservation in the Chesapeake Bay watershed. The new Chesapeake Bay States' Partnership Initiative will support Bay-area farmers, building on a \$1.1 billion investment made by the USDA's Natural Resources Conservation Service over the past decade. USDA is also announcing a new task force -- jointly with the U.S. Environmental Protection Agency (EPA) -- to better quantify the voluntary conservation efforts of farmers in the bay watershed.

The USDA Natural Resources Conservation Service will prioritize support of practices that reduce nitrogen and sediment, improve management of livestock and waste, and conserve wetlands, all of which align with the bay's water quality objectives to reduce nutrient loading, restore wetlands and install riparian buffers.

Practices include riparian buffers, cover crops, waste storage facilities, and prescribed grazing among others. This funding will allow states to respond to the high demand from bay area farmers for additional conservation support, as well as Farm Service Agency to identify needs and opportunities for buffer management on acres that may be coming out of the Conservation Reserve Program.

PFB State & Local Affairs Specialist Kyle Kotzmoyer Urges Members to Get Involved in Policy Development
