Pandemic Assistance to Hog Producers

The USDA announced additional pandemic assistance to hog producers who sold hogs through a negotiated sale during the COVID-19 pandemic. The new program, the Spot Market Hog Pandemic Program (SMHPP) is part of the USDA's larger initiative to address gaps in previous assistance for hog farmers.

USDA is offering SMHPP because packer production was impacted by the COVID-19 pandemic through employee illness and supply chain issues, which led to fewer negotiated hog sales and lower market prices. Producers who sold hogs between April 16, 2020 and Sept. 1, 2020 may be eligible to apply.

"Previous pandemic assistance used flat rates across the hog industry, and this didn't take into account the various levels of harm felt by different producers," said FSA Administrator Zach Ducheneaux. "We worked closely with industry partners and USDA's Agricultural Marketing Service to target assistance to hog producers who were hit the hardest during the pandemic. This is one more example of our efforts to provide new, broader, and more equitable opportunities for farmers, ranchers and producers."

The Department has set aside up to \$50 million in pandemic assistance funds through



the Coronavirus Aid, Relief and Economic Security (CARES) Act for SMHPP. The FSA will begin taking applications on Dec. 15.

SMHPP payments will be calculated by multiplying the number of head of eligible hogs, not to exceed 10,000 head, by the payment rate of \$54 per head. FSA will issue payments to eligible hog producers as applications are received and approved. For more information on who is eligible and how to apply, visit farmers.gov/smhpp

Broadband Bill Passed

The Pennsylvania General Assembly passed House Bill 2071 in December, which will help bridge the digital divide when it comes to rural broadband in the state. The bill will establish the Pennsylvania Broadband Development Authority, that will address the lack of reliable broadband service in rural areas. The bill now heads to the governor for his expected approval.

The bill addresses the need for broadband expansion by creating an authoritative body that can implement a statewide broadband plan, and serve as a point of contact for entities that look to expand or start new services. The Broadband Development Authority will also oversee the allocation of federal dollars to these projects.

"We are very pleased to see this crucial bipartisan effort to address our lack of broadband access," said PFB President Rick Ebert. "Rural families and farm businesses have been under served, and the need to have access to high-speed internet is essential to compete and participate in the digital age."

The bill also puts in place safeguards to ensure that areas that have the slowest internet speeds or lack of access are prioritized, and that money and resources are being distributed to those areas first.

Pennsylvania Farm Bureau advocated for the passage of the bill.

DEP Energy Efficient Rebate Program

The PA DEP has a new rebate program for farmers to help with cost of energy efficiency projects. The Ag Energy Efficiency Rebate Program is offering rebates to defray the costs of installing LED lighting or variable frequency drives on the farm, which can save energy while saving money on utility bills.

Applications will be accepted through March 31, 2021 on a first come, first serve basis as long as funding is available. The available rebates will pay for 50% of the equipment costs, up to \$2,000.

Agritourism Signs & Wristbands

PFB has signs and wristbands available for purchase to help agritourism operators ensure they are protected under the new law limiting civil liability.

Signs are compliant with Act 27 and cost \$62 each plus shipping. They are 24"x36", made from .040 aluminum and have 3/4" rounded corners. They are waterproof and UV safe and guaranteed to last a minimum of 5 years and not rust.

Wristbands are also available which are complaint with Act 27 and cost 5.5 cents each plus shipping. They are 1"x10" made from Tyvek and include necessary legal disclaimer, in the correct font size and bold type, on the back.

Annual Dues

Reminder that your annual dues renewal for 2022 are now due. The annual membership did increase to \$100 per the by-law changes that were voted on at June's meeting. Remember to get your dues paid in order to keep your discounts and benefits!

Farm Vitality Planning Grant

The Farm Vitality Planning Grant Program will help fund professional services for those planning for the future of a farm. The program will enhance the long-term vitality of Pennsylvania's farms through sound business planning, efficient transitions of farm ownership, strategic farm expansion, diversification of agricultural production, and building a team of financial and technical expertise as a resource for Pennsylvania's farmers.

Grants may be used for expenses related to the following projects:

- Creating or obtaining business plans or management strategies to enhance the long-term economic viability of a farm.
- Creating or obtaining plans for the transition of ownership and operation of a farm to new owners and operators.
- Creating or obtaining plans for transfer of ownership and operation of a farm within the farmer's family.
- Creating or obtaining business plans to diversify an existing agricultural operation to new or different forms of agricultural production.
- Creating or obtaining business plans for a farm expansion or to seek financing for farm growth.
- Creating or obtaining plans to maintain the long-term economic viability and protect the investment of public funds in preserving farms that are subject to perpetual agricultural conservation easements acquired under the Agricultural Area Security Law, for agricultural production.

Who is eligible:

• Farmers, Prospective farmers, and others in support of the grant's objectives.

This is a reimbursement grant. The maximum grant amount is \$7,500 and is limited to 75% of project costs. The amount of reimbursement is based on actual eligible costs submitted by an approved applicant for an approved project during the fiscal year in which the grant is offered. Grants will be awarded on a funds -available basis. Grant money may not be used to reimburse any portion of the project costs which are being paid or reimbursed under another federal or state grant program.

Applications are for one, single project. Separate projects require separate applications.

Applications are online only, through Pennsylvania's Single Application for Assistance online application system, at: www.esa.dced.state.pa.us
Applications must be submitted through the Single Application for Assistance online system starting April 19, 2021 at 8:00 a.m. and will be received until available funding is exhausted.

Anything Is Possible For Rural Entrepreneurs

Even before the Internet connected us instantly phone to phone, Hugh McPherson was reaching out. Penn State Extension's Larry Yeager brought the first farmer interested in doing a corn maze to McPherson's fledgling Maize Quest corn maze attraction in 1998. It was a simple network, just two farmers talking.

In its 25th season at the home farm, Hugh & Maize Quest reaches thousands of agritourism operators worldwide through social media, email blogs, and online classes. "We evolved with technology," says McPherson, 5th generation farmer, and Maize Quest's founder. "Each step along the way we discovered new ways to reach guests for our home farm and farmers to help with their farms."

And help they have. Maize Quest designs corn mazes for over 80 locations each season, then cuts those mazes with sophisticated GPS systems for pinpoint accuracy. Hundreds of thousands of guests visit these 80 farms, collectively bringing tourism dollars into rural economies.

This benefit to the rural landscape in 24 states, Canada, and even the UK starts in tiny Gatchellville, PA, a town too small for a zipcode.

"The message to rural kids is that there are no limitations," says McPherson. "Your phone can open the world to your farm. The Internet can take your idea, your business, to the world."

This online presence brought Major League Baseball (MLB) to Maize Quest for what would become a crazy, national-stage project. Once contacted based on previous work with logocentric corn mazes, the production company signed Maize Quest into secrecy.

Farmland Preservation Applications

Landowners interested in Farmland Preservation, the York County Ag Land Preservation Office reminds you applications can now be submitted for the 2022 Application Round. Deadline is February 15, 2022, but we encourage fall appointments to ensure you submit a qualified application well before the deadline. Please call (717)840-7400 for an Application-Literature Packet, or to make an Appointment. Visit our website and read about farm eligibility, qualification, the ranking and selection procedures, and the deed of easement restrictions. Go to www.yorkcountypa.gov Property and Taxes, find Ag Land Preservation, in the drop down menu. The 2022 application is available to download. Please remember we moved to 2401 Pleasant Valley Road Suite 101, York Pa 17402. Across from Heritage Valley Credit Union and behind Diehl Toyota.

Dairy Margin Coverage

Dairy producers are now able to sign up for the USDA's Dairy Margin Coverage (DMC) program. Thisprogram enables producers to get coverage through the safety-net program for another year. The USDA also expanded the program to allow dairy producers to get additional assistance through a new Supplemental DMC.

"Dairy Margin Coverage is a critical safety-net for producers, and catastrophic coverage is free. These DMC updates build on other efforts of the Biden-Harris Administration to improve DMC and other key USDA dairy programs," Under Secretary for Farm Production and Conservation Robert Bonnie said. "We encourage dairy producers to make use of the support provided by enrolling in supplemental coverage and enroll in DMC for the 2022 program year."

From USDA: "Eligible dairy operations with less than 5 million pounds of established production history may enroll supplemental pounds based upon a formula using 2019 actual milk marketings, which will result in additional payments. Producers will be required to provide FSA with their 2019 Milk Marketing Statement.

"Supplemental DMC coverage is applicable to calendar years 2021, 2022 and 2023. Participating dairy operations with supplemental production may receive retroactive supplemental payments for 2021 in addition to payments based on their established production history.

"Supplemental DMC will require a revision to a producer's 2021 DMC contract and must occur before enrollment in DMC for the 2022 program year. Producers will be able to revise 2021 DMC contracts and then apply for 2022 DMC by contacting their local USDA Service Center."

According to the USDA, "After making revisions to 2021 DMC contracts for Supplemental DMC, producers can sign up for 2022 coverage. DMC provides eligible dairy producers with risk management coverage that pays producers when the difference between the price of milk and the cost of feed falls below a certain level."

To be eligible, producers must certify that the operation is commercially marketing milk. The signup period for DMC 2022 enrollment runs from Dec. 13, 2021, to Feb. 18, 2022.

Livestock Mandatory Reporting Extension

The House on Dec. 8 passed a pair of livestock bills supported by the American Farm Bureau Federation. One of the measures would extend Livestock Mandatory Reporting, while the other would create a contract library for the beef cattle industry, similar to the pork industry catalog.

Livestock Mandatory Reporting was extended through mid-February in the most recently passed continuing resolution, but the measure passed this week in the House would extend LMR through the end of the 2022 fiscal year, which ends on Sept. 30, 2022.

The other livestock measure, the Cattle Contract Library Act of 2021 (H.R. 5609), would create a library for cattle contracts within USDA's Agricultural Marketing Service. The bill would require packers to report terms of alternative marketing agreements between packers and producers, equipping ranchers with additional market data needed to make informed marketing and business decisions. The USDA library would provide producers with key details on cattle contracts, including the type and duration.

Both bills "provide crucial information, which is needed now more than ever as prices skyrocket at the grocery store while payments to farmers lag behind," AFBF President Zippy Duvall said in a statement.

He continued, "We appreciate the leadership demonstrated by Agriculture Committee Chairman David Scott and the work of Representatives Dusty Johnson and David Cuellar. Their work on behalf of America's ranchers helped create overwhelmingly bipartisan support for both pieces of legislation. We urge the Senate to work together in a similar fashion to ensure market fairness for farmers and ranchers working to put food on dinner tables across the country."
