

Bylaw Changes

The following changes are being proposed to Butler County Farm Bureau Bylaws, these changes will be voted on at our annual meeting on October 3, 2024 at the Prospect Fire Hall.

The recent state bylaws changes deleted the former "Friend of Farm Bureau" category, created a definition for "member in good standing," provided for a member suspension and expulsion process, and clarified conflict provisions for state directors. Consequently, counties have discretion to implement similar changes to their county bylaws. Notably, many counties already have language indicating that any "member in good standing" definition adopted by PFB shall automatically apply at the county level. Thus, PFB's recent change to the definition of "member in good standing" already applies to such counties, (*Butler Counties Bylaws follow the states definition*).

Article II Membership, Section 2 Classes
Remove Friends of Farm Bureau
Section 6. Dues. a. Voting Member:
County Portion Dues Amount.
b. Remove Friends of Farm Bureau
Section 8. Expulsion.

A member who is not in good standing may be expelled by a 2/3 vote of a quorum of the Board if the Board believes that the member's transgression is serious enough, provided that notice and a hearing are given to the member. The notice shall include, with sufficient detail, the reason and relevant dates for potential expulsion. The Board shall issue and provide to the member a written decision within 30 days of the hearing.

Section III
Board of Directors
Section 2. Qualifications

For purposes of this section, a "conflict" shall be deemed to exist where a person is employed by or serves as an independent contractor or agent with: (1) this Farm Bureau; (2) Pennsylvania Farm Bureau; (3) American Farm Bureau Federation; (4) any charitable foundation, subsidiary, or related organization of either Pennsylvania Farm Bureau or American Farm Bureau Federation; or (5) any company in a contractual relationship with this Farm Bureau or the Pennsylvania Farm Bureau where the contract is valued in excess of \$500,000 annually. Volunteer work for or on behalf of any of the previously listed entities shall not be deemed a conflict. For potential conflicts involving a contract valued under \$500,000, the PFB conflict of interest policy and related disclosures shall apply.

Additionally, counties are encouraged to consider making other bylaws changes not directly related to the recent state amendments. These changes are: electronic notice; quorum requirements; the number of Board Directors; and Treasurer bonding requirements. These suggested changes stem from common questions and issues raised by counties in recent years. Changes in Blue.

Section 8. Meetings.

Section 8. Meetings. The annual meeting of voting members shall be held in September or October of each year, the date and place to be selected by the Board of Directors. Regular and special meetings of voting members may be called by the President, or by two-thirds vote of the Board of Directors, and shall be called by the President upon written request signed by at least one-fourth of the voting members.

Section 9. Notice.

Notice of meetings of voting members and all matters concerning this Farm Bureau shall be deemed to have been duly given by: (1) placing in the mail, postage prepaid, to the last known post office address of the voting member, at least 20 days prior to such meeting, notice thereof in writing; or (2) email to a voting member's last known email address, at least 20 days prior to such meeting or matter. A notice of a meeting or matter appearing printed in an official publication of this Farm Bureau, mailed or emailed to voting members in good standing at least twenty 20 days prior to the meeting or matter shall be deemed to comply with this provision.

Section 1. Quorum.

Twenty of the voting members in good standing shall constitute a quorum for the transaction of any and all business at any annual or special meeting, and the favorable vote of a majority of such members present in quorum shall be necessary for the determination of any matter, except that a lesser number may adjourn from time to time

Article II Board of Directors

Section 1. Number and Authority.

The business and property of this Farm Bureau shall be managed and controlled by a Board of Directors of 9 voting members to be elected at the annual meeting of this Farm Bureau. In addition, if there is a county women's or leadership committee, the chair(s) shall be an ex-officio member of the board of directors with voting powers. The term of office of directors shall be three years and until their successors are duly elected and qualified.

Section 3. Election of Directors.

At the first meeting of voting members, and at each annual meeting of voting members thereafter, a Board of Directors shall be elected to serve until their successors are duly elected and qualified. All elections for directors shall be by verbal vote or by ballot, which may be accomplished by mail or electronic ballot methods, unless this rule is waived by unanimous consent of all voting members present or by proxy.

Section 4. Meetings.

The Board of Directors shall meet as soon as practicable after the annual meeting of this Farm Bureau and shall meet in regular session as often as may be necessary, to conduct the business of this Farm Bureau. The regular meetings of such Board shall be held on such dates and at such time and place as may be fixed by the Board of Directors. Special meetings may be called by the President and shall be called by the Secretary upon request in writing signed by one-third of the entire number of directors. Notice of meetings shall be given in such manner as provided in Article II, Section 9. Attendance at any meeting shall constitute waiver of notice thereof.

Section 5. Quorum.

A majority of the Board of Directors shall constitute a quorum, and a majority of the directors in attendance at any meeting, shall, in the presence of a quorum, decide its action. A minority of the board present at any meeting may, in absence of a quorum, adjourn to a later date, but may not transact any business. Section 6. Removal from Office. The following shall constitute sufficient grounds for the removal from office of any officer or director without the necessity of a vote of the Board of Directors: a. Death. b. Being or becoming an employee of the Pennsylvania Farm B

ARTICLE V Officers

Section 6. Treasurer

The Treasurer shall keep a full and accurate account of receipts and disbursements and deposit all money, checks, and other obligations to the credit of this Farm Bureau in such depository or depositories as may be designated by the Board of Directors or Executive Committee; shall disburse the funds of this Farm Bureau as ordered by the Board of Directors, or the Executive Committee, taking proper vouchers for such disbursements; shall render a statement of account and transactions whenever required by the Board of Directors or Executive Committee; and generally shall perform all the duties incident to the position of Treasurer, subject to the control of the Board of Directors.

The Treasurer shall be required by the Board of Directors to furnish a bond conditioned for the faithful accounting for the funds and property in the Treasurer's custody in such sum and with such surety or sureties as may be fixed and required by the Board of Directors or Executive Committee. The premium on such bond shall be paid by this Farm Bureau

Article VIII
Amendment of Bylaws

Section 3. Study Committee

To ensure the bylaws are relevant and effectual, the President shall appoint a bylaws study committee no less than every third year

Agritourism Liability - For more information go to Agritourism Liability - Pennsylvania Farm Bureau (pfb.com). In June 2021, Gov. Tom Wolf signed Legislation to limit civil liability for farms engaged in agritourism. Pennsylvania Farm Bureau's advocacy leadership played a key role in securing this long-sought victory for Pennsylvania agriculture. The new law, Act 27 of 2021, gives agritourism operations reasonable protection from lawsuits arising from circumstances beyond their control. However, there are certain steps agritourism operators must take to receive this protection. PFB has signs available for purchase, along with wristband tickets, that meet the requirements of the new law and has put together a helpful guide to help agritourism operators ensure they are taking the proper steps to ensure they are protected.

Agritourism Law Webinar with PFB's Joe Montenegro and Penn State Law's Brook Duer How can I get signs?

Signs are compliant with the sign posting requirements of Act 27 and cost \$65 each plus shipping.

The 24-inch by 36-inch signs are constructed from .040 aluminum and have ¾-inch, rounded corners.

They are waterproof and UV safe and are guaranteed to last a minimum of five years and not rust.

Purchase Warning Signs





Read your written agreement or the back of your ticket. Under Pennsylvania law, except for limited circumstances, an agritourism activity provider is not liable for any injury to or death of a participant resulting from an agritourism activity. Do not participate in the activity if you do not wish to waive liability.

How can I get wristbands?

Outside (top) displays PFB logo and inside (bottom) of band displays visitor agreement.

Wristbands are compliant with Act 27 and cost 4.9 cents each plus shipping.

The 1" x 10" wristbands are made from Tyvek ® and include the necessary legal disclaimer, in the correct font size and bold type, on the back.
