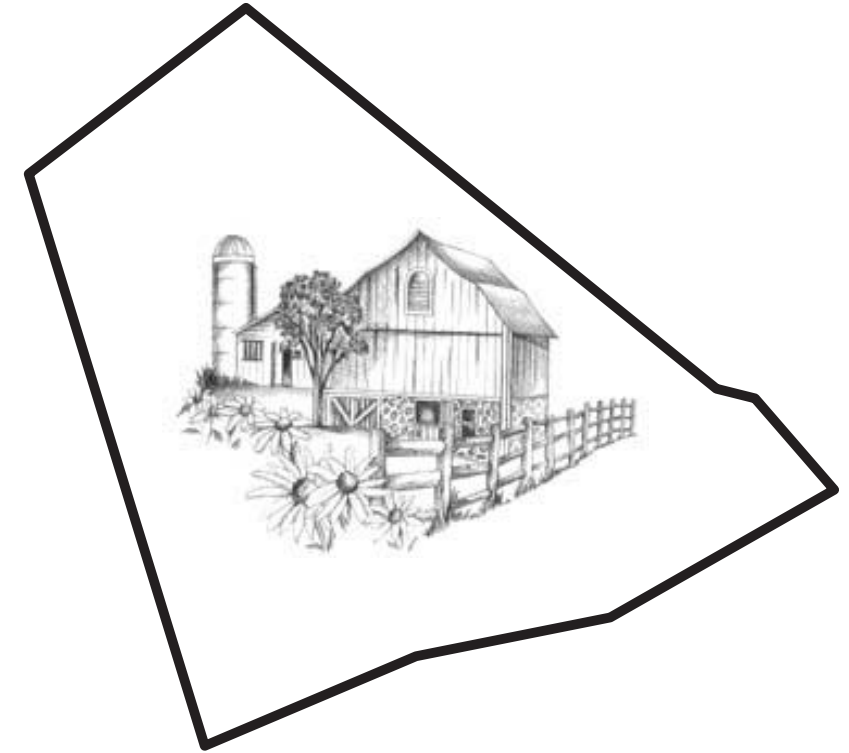

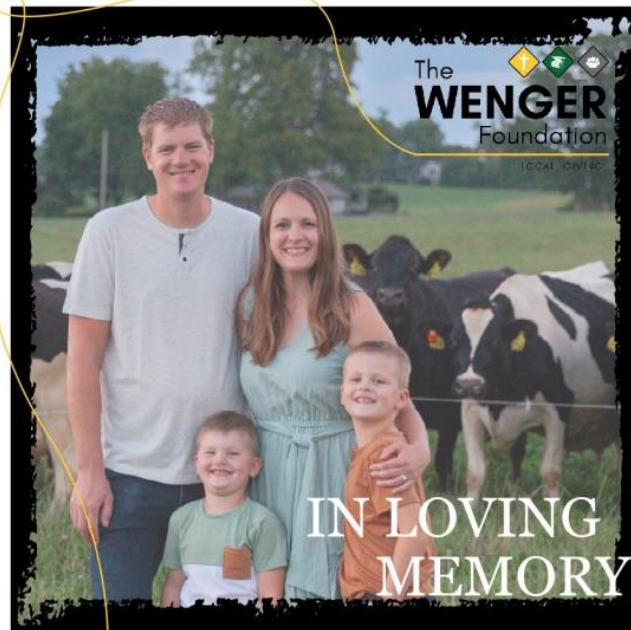

Prop 12 Legislative Fix Needed in Farm Bill

Farm Bureau is supportive of House Ag Chairman "GT" Thompson's proposed solution to Proposition 12 (Prop 12) in farm bill. Section 12007 of H.R.8467 clarifies that states and local governments cannot impose standards of production, as a condition for sale or consumption, on livestock produced outside of their borders. This protects a producer's right to participate in a national market without having to adhere to a patchwork of costly compliance requirements. It also protects the rights of states and local governments to impose production standards as they see fit, but only for livestock raised within their own borders. PFB has explicit policy supporting Section 12007, and appreciate the Chairman's efforts to find a commonsense solution that we hope everyone can get on board with when it comes time for a vote on the House floor. PFB would also like to thank the 51 county Farm Bureaus who signed onto the recent stakeholder letter which was sent to House Ag on May 21. Additionally, the American Veterinary Medical Association and American Association of Swine Veterinarians sent letters supporting Section 12007.

Let Your Voice Be Heard During Policy Development

One of the many things that make Farm Bureau a great organization is that it is completely driven by the grassroots. Everything the Farm Bureau organization supports and opposes is determined by the farmer members. This is all done through a process known as policy development. It all starts with an issue. That issue is addressed with a policy and if passed at the Pennsylvania Farm Bureau annual meeting, this policy becomes an official stance of the Pennsylvania Farm Bureau. The organization's members and directors of government affairs can then discuss these policies with our elected officials and encourage them to create solutions for these problems. Are you running into issues on your farm that are a detriment to your ability to successfully and effectively farm? We want to know about it! From The President's Desk

It is hard to believe we have already reached the month of June and 2024 is nearly half over. This spring was certainly an interesting one, but the general consensus is that the crops have been planted and we are well on our way to another successful year on the farm. Many years ago, I learned the old adage "if ya ain't complaining, ya ain't farming!" It is easy to focus on what we are walking through currently and not think about where we have been or what the future looks like. A year ago at this time, we were in the middle of a brutal drought where many of us did not get a decent measureable rain for about 7 weeks. The grass was crunchy, the first cut hay yield was lower than usual, and the young corn looked rather bleak in the field. However, this year God has faithfully provided with wonderful rain and "knee high by the fourth of July" looks like a pretty sure thing.

Farming is never easy and in the midst of the trials, it is easy to become discouraged. Thankfully, we can look back and see that what comes up goes down and then goes back up again. Live cattle are selling at record prices while our country faces the lowest beef herd numbers in 70 years. Grain prices are low which fuels the storm with lower costs in feed. Even though beef prices have risen, it has not had a dramatic effect on consumer purchasing. Regardless of what we hear on the news, consumers are choosing high quality, American grown beef. What's particularly interesting is the surge in consumers purchasing local beef and other farm products directly from the farm.

Almost daily we hear about some ridiculous idea to regulate agriculture that makes us scratch our heads. Regulating cow farts, turning vegan, banning a means of production. It is all about telling a story. Consumers are buying directly from the farm because they enjoy developing a relationship with the men and women who grow their food. It instills confidence in them.
