The Annual York County Farm Bureau meeting was held on Sunday. September 8 at the Red Lion Rec Center. Thank you to all those who attended for the luncheon and annual meeting. County is submitting 4 policies for PFB Annual Meeting listed below. Thank you to Senator Kristin Phillips -Hill for attending and updating those in attendance what is happening at the Capital as well as Todd Horner from Shipley who explained the discounts offered to Farm Bureau members! Policies:

- Amendment to Federal Policy 1.14: A state by state depredation order for the taking of predatory (Insert) > and biosecurity risk of < Black Vultures.
- 2. Whereas, the states of Virginia and Maryland have decommissioned a large portion of their fossil fuel power plants and now produce less reliable electrivity, and Whereas Virginia's current data center plans would consume more power than New York City, and Whereas every kilowatt of exported power increase the cost of power to PA residents, and Whereas new transmission lines have always relief on threats of eminent domain, be it resolved that the York County Farm Bureau urges Pennsylvania to enact policy that would reject calls from grid operator PJM to construct any additional transmission lines solely for he purposes of providing power to Maryland and Virginia.
- The flying of drones or any kind of photo or video equipment without landowner or property manager consent over agriculture animal operations and commercial food processing facilities such as meat packing plants) should be treated in the same manner as physical trespass.

Member Spotlight: Caleb Staples & Anna Benton

Caleb Staples & Anna Benton were married in October 2023 so Happy 1 Year Anniversary to this lovely couple! Caleb was raised on his family's fifthgeneration farm, helping to grow corn, soybeans, small grains, hay, and hogs. He began his commercial goat operation in 2018, partnering with his grandfather to form Shady Nook Meat Goats. At its peak, the operation managed thirty commercial breeding does. In 2022, after selling the business, Caleb shifted his focus to raising registered Boer goats, bringing his experience into a new business model at NovaRoot Farm. Anna grew up riding horses from age five and joined Caleb in his commercial goat operation in 2020. She applied much of her past equine management practices to Shady Nook's and now NovaRoot's operations. Today, Caleb and Anna work side by side to manage and grow the farm. They have plans to expand their business in the upcoming season by leasing more ground, purchasing and breeding higher quality does, and obtaining new feed customers. Together, they are dedicated to the farm's day-to-day success and longterm growth.



NovaRoot Farm LLC is a proud first-generation farm owned and operated by Caleb Staples and his wife, Anna Benton. Like many in agriculture, Caleb had to forge his own path when the family farm wasn't an option. Through God, hard work, and love, Caleb and Anna have built a successful operation, Nova-Root Farm. The couple farms approximately 20 acres of hay fields, producing quality small square bales while breeding and showing registered ABGA Boer goats. They also serve the local agricultural community by selling ADM and MoorMans ShowTec feed. By offering ADM feed products, Caleb and An-

na strive to provide nutrition solutions tailored to benefit each customer's farming operation.

Founded in 2024 after purchasing their farm, Caleb and Anna chose the name "NovaRoot" to symbolize their commitment to innovation while staying rooted in the foundation of agriculture. The couple aims to promote nontraditional operations, advocate for the young farmer, and implement more family farm succession plans, firmly believing in the importance of family farms. Farming is not just a business but a lifestyle the couple is blessed to be a part of.

Caleb joined the York County Farm Bureau Board in 2024 attending the PFB Legislative Day in Harrisburg! Anna has spearheaded the YAP (Young Ag Professionals) for York County with two events for 2024 already growing!

Why New Power Lines?


The spring issue of your YCFB newsletter described the \$5.4 billion proposed project to build new high voltage lines intended to carry power to Northern Virginia. Since then, we have seen some of those projects go "public", with the proposal of the Maryland Piedmont Reliability Project (MPRP) that would build a new 500kv line across Baltimore, Carrol, and Fredrick counties. Chances are good if you drive anywhere in the northern parts of those counties you will see protest signs along the roads. The Maryland Farm Bureau has reacted quickly and condemned the project.

So why the new lines?

As the internet has grown over the last three decades, Louden County Virginia has grown to have the largest concentration of data centers in the country. But recently, the advent of artificial intelligence (AI), has caused a step change in both the demand for, and power consumption of new data centers in Louden. Goldman Sachs forecasts a 160% increase in demand in the next 5 years. In fact, the current PJM forecast for Virginia data center demand is the equivalent to TWO New York Cities' worth of power!

The grid planner, PJM, treats this demand the same way that it would treat proposed demand from organic growth of a city, or a huge cluster of hospitals, or any other worthy cause. It takes the forecast, looks to see if there is sufficient generation in the area, and if there is a shortfall, it asks member utility companies to propose transmission solutions from any place that has sufficient generation. Why transmission? Because PJM has no authority to order generation.

The obsolete but current state of the rules implies that America's most affluent companies can propose as many data centers as they like in Virginia, resulting in eminent domain claims on your land in

much higher power
costs for PA consumers, and would
force PA ratepayers to help pay for
construction of
those new
lines. Scared yet?

That's why at this year's annual meeting, the YCFB approved policy that would encourage our legislators to adopt legislation that would prevent any new lines built to export power to Maryland and Virginia. We feel that enough is enough.

Wildlife Update

Voting on SB67 takes placed October 1st in Game & Fishers House Committee! House Version of Sunday Hunting and Wildlife Crop Damage Package Passed House: The House successfully passed Representative Steele's package of wildlife bills, HB 2106-2108, the week of June 24. HB 2106 – 2108 would accomplish the following:

- Increase hunting trespass penalties.
- Streamline crop damage mitigation programs.
- Require at least one member of the PA Game Commission to be defined as a farmer.
- Create a system by which licensed hunters can easily be contacted by farmers.
- Repeal the Sunday hunting prohibition.

Farm Bureau thanks the House for working with PFB to craft and pass this legislation. This could not have been possible without working with multiple wildlife and sportsman organizations to find an effective solution for all parties involved. PFB is thankful to see the passage of these bills in the House and looks forward to the Senate acting soon. See below for the number of votes each bill received and links to their exact language. • HB 2106 (129-73) • HB 2107 (164 - 38) • HB 2108 (132-70) Senate Version of Sunday Hunting and Wildlife Crop Damage Package: The Senate successfully passed SB 67 (which also includes the crop damage package of SBs 1086- 1089) with a vote of 33-17. This comprehensive bill addresses crop damage mitigation and allows for Sunday hunting. More specifically, it includes stricter trespass penalties and streamlined deer carcass removal. SB 67 now awaits action by the House Game and Fisheries Committee.
