# **Bud Wills Honored At Legislative Breakfast**



Bud Wills, a longtime member of the CVF Board and Government Relations Director, was recognized for his many years of service at the

Legislative Breakfast held on February 21. The breakfast was his last official GRD event. Bud has organized many legislative farm tours, legislative breakfasts and made many trips to Harrisburg to meet with legislators over the last 15 + years.

The breakfast was well attended by our state and

local lawmakers. Senator Scott Hutchinson and Representative Josh Bashline gave updates on what is happening in Harrisburg. Sen. Hutchinson focused on the





state budget proposal that he felt was way out of line with the revenue coming in. Rep. Bashline addressed the issue of legalizing marijuana, emphasizing that the legislature needs to examine the criminal impact of

legalizing it.

Other issues discussed included the impact of large deer herds on agriculture and problems on township roads.

# Harrisburg Legislative Day April 8

Jordan Siegel and Paul Stahlman joined hundreds of Pennsylvania Farm Bureau members who traveled to Harrisburg to discuss Pennsylvania Farm Bureau's priorities for 2025 with state lawmakers as part of PFB's annual State Legislative Conference.

PFB members, legislators and their staff attended a luncheon where they heard from key state officials, including Governor Josh Shapiro, Secretary of Agriculture Russell Redding, House Agriculture and Rural Affairs Chair Rep. Eddie Day Pashinski, House Agriculture and Rural Affairs Minority Chair Rep. Dan Moul and Senator Judy Schwank, the Senate Agriculture and Rural Affairs Minority Chair.

Gov. Shapiro reinforced his commitment to Pennsylvania's agricultural industry at the conference. Shapiro also emphasized the partnership between the legislature, Farm Bureau and his administration which has been working hard to continue to keep agriculture a top priority in the 2025-26 state budget.

"I made a commitment that we would put agriculture at the center of our work to grow our economy here in Pennsylvania and create opportunities for farmers across our commonwealth to help our ag industry grow," Shapiro said. "I told



you that agriculture would be a top priority for my administration and I'm back here today to say that we delivered. That is because of the extraordinary partnership that we have with the folks in this room and the Farm Bureau here in Pennsylvania, who do incredible work representing you every single day in the halls of power."

During a news conference at the Capitol, PFB President Chris Hoffman shared PFB's 2025 state priorities, including the challenges that wildlife damage presents to farmers' bottom lines. Hoffman noted that PFB has been working with legislators in both the House and Senate to help mitigate this. Other topics discussed included energy, environmental issues, dairy and the state budget.



"Today could not be possible without the support and dedication of our Farm Bureau members," Hoffman said. "The members you see here today have either taken time away from their operation, taken off work or missed out on precious family time to spread the word of agriculture. I cannot

express my gratitude to them enough for what they do day in and day out."

### State Mandated Reporting for Businesses in 2025



The Pennsylvania Department of State is now requiring **Annual Reports** for nearly all registered businesses, beginning in **2025**. This replaces the older **decennial report** system.

### Who Must File?

- For-Profit
   Corporations (domestic & foreign)
- Limited Liability Companies (LLCs) (domestic & foreign)
- Nonprofits, Limited Partnerships, and LLPs

Each entity type has a different due date:

Entity Type Annual Due Date (starting 2025)

Domestic & Foreign Corporations - June 30

Domestic & Foreign LLCs - September 30

Nonprofits - December 31

### What's Included in the Report?

- Business name
- Jurisdiction of formation
- Registered office address
- Principal office address
- Name of at least one governor (director, member, partner, etc., depending on type of association)
- Names and titles of the principal officers, if any
- Entity number issued by the Pennsylvania Department of State

#### How to File:

You can file online through the Pennsylvania Department of State's Business Filing

System: https://file.dos.pa.gov

Annual Reports submitted online will be automatically approved

### **Important Notes:**

- There is a \$7 filing fee, except for nonprofits which are exempt from the fee.
- This is a **yearly requirement** not a one-time filing.
- Missing the deadline may result in administrative dissolution or loss of registration, which can prevent your business from legally operating in Pennsylvania.

# Why This Matters for Farm and Ag Businesses:

Even if you're not a large operation, if your farm is registered as an LLC or corporation, this applies to you. It's a quick filing but critical to keep your registration active.

# Congressman Glenn "GT" Thompson Honored with Golden Plow Award

The American Farm Bureau Federation and Pennsylvania Farm Bureau on Tuesday, April 22, presented



House Agriculture Committee Chairman Glenn 'GT' Thompson with AFBF's Golden Plow award at Wasson's Farm Market in State College.

The Golden Plow is the highest honor the organization gives to sitting members of Congress. This is the second Golden Plow award for Chairman Thompson. He was previously honored in 2014.

"From the moment he took office, Chairman Thompson has worked tirelessly on issues impacting farmers, ranchers and rural communities," said AFBF President Zippy Duvall. "His unwavering support for hardworking farm families has earned him the Friend of Farm Bureau award for eight consecutive sessions, so presenting him with the Golden Plow award seems only natural. Chairman Thompson's dedication to rural America is needed now more than ever, and his character is the epitome of what a Golden Plow recipient should be."

"Agriculture is the backbone of the American economy, providing the country with food security, which translates to national security," Rep. Thompson said. "As Chairman of the House Committee on Agriculture, it remains a true privilege to serve the hardworking men, women, and farm families who feed, fuel, and clothe the world. I am honored to receive the Golden Plow Award once again and thank Pennsylvania Farm Bureau for their continued advocacy on behalf of the Commonwealth's number one industry."

The new CVF By-laws were presented and passed with the vote of the members in attendance. State Board member Ray McMinn made the point that the legislators do listen to the concerns of our grassroots organization. The meeting concluded with an auction of the items brought to the meeting that raised \$530 for the Raise the Barn Campaign.
