# **Annual Meeting Reviews Record Number of Policies**

Two hundred four policies were put under consideration at the 74<sup>th</sup> Annual PFB Meeting held at the Hershey Lodge and Convention Center November 17-19. Of these policies, 144 were approved by the 175 delegates seated from 54 Farm Bureau chapters across the state. Those approved will now be reviewed by our professional PFB lobbyists.

The delegates debated a wide variety of policies including items affecting the state policies on Ag, health and safety, dairy, local government and zoning, farmland preservation, taxes, natural resources, stormwater, mineral extraction, education, foreign investment and farmland ownership, vehicle code and transportation, labor, hunting and fishing laws, wildlife management and private property rights to name a few.

As a first-time delegate, I found the debating quite interesting and was impressed with the reasonable pros and cons that were expressed.

I have a new appreciation for the legislative work that PFB does for our grassroots membership.

Three of CVF's policies were brought to the table but only one was passed. It states: We recommend Tianeptine be defined as a controlled substance in the State of PA.



## Member Starts Hay Drive NW PA Farmers Helping Farmers

Brittany Eisenman and her husband Corey have been working nonstop to collect hay and monetary donations to support farmers facing total devastation from the effects of Hurricane Helene.

As of November 13, they have seen off 714 round bales, 1,890 small bales, 55 large squares and 2 large round bales of straw.

Other items sent include T posts, woven wire, fencing supplies, goat, chicken and livestock feed, small animal supplies, boots, lumber, insulation, chainsaws and as well as human needs

They have more hay promised from area farmers, but they really need the trucks to haul them. Brittany estimates it takes between \$1200 to \$1500 to get the trucks down and back. If you know of someone who could help, please contact her. **Contact info is on page 4.** 

Brittany was recognized for this work at the annual meeting on Sunday, November 17.

### **CVF Scholarship Changes**

Our CVF Scholarship winners have been drawn randomly at the Spring Meeting in the past. Many felt that this wasn't fair to the students who really have applied themselves. The Board has decided to put our scholarships into the hands of the Bridge Builders Community Foundation.

We will be awarding two \$750 scholarships in 2025. Applicants can apply online from the last week of January to the first week of March.

The foundation covers Venango, Clarion and Forest counties. Our criteria include: 1. Be a member or from a member household of the CVF Farm Bureau; 2. GPA of 2.0 or above; 3. Be enrolled to attend one of a variety of post-secondary institutions for the next year school year. These include four-year colleges, business colleges, graduate schools, technical schools, trade schools, and community colleges; 4 Plans to major in Agriculture or an Agriculture-related field.



We hope that this will encourage students to apply and to expect a fair judgement of their academic records.

# Annual Fall Meeting Held August 20



State Representative
Donna Oberlander was
congratulated on her
retirement by
Congressman Glenn "GT"
Thompson. Rep
Oberlander has served
Clarion and Armstrong

counties for the past 16 years. "GT" praised her for her lasting impact on our commonwealth. She has been a dependable leader and was the first woman to serve as both Republican Whip and Policy Chairman. She has been a member of CVF for the past 21 years.

Leah Smith, Director of GIS, Clarion County, gave a presentation on Clean and Green which will begin in Clarion County in 2026 with the new property assessments.

PFB Vice-President Tommy Nagle was also present. He said the county chapters are the backbone of PFB. We need to tell our story and be proud of what we are doing, especially since farmers are producing more food now than in any time in history.

Tyler Fraser, Bud Wills and Dave Yeany were reelected to the Board of Directors.

Approximately 60 members were in attendance.



Nelson Smith talked about his four-generation family farm that has been in production since the 1800s. CVF's first Legislative Tour was held on his farm fifteen years ago.

## Legislative Farm Tour Sweet Breeze Farm, Mayport

Dairy robotics was the big draw for this year's Legislative Tour at the Sweet Breeze Farm, Mayport, owned by Nelson and Jared Smith. The Smiths are milking around 160 dairy cows in a modern robotic milking system. The cows go through the milking parlor on their own. They are fed, washed and milked entirely by robots. Jared said that their cows produce 1200 to 1300 gallons per day. A computer system tracks each cow's production and needs.



Nine members of the Redbank Valley FFA and their adviser Kate Kronen came to see what robotic milking was all

about. They also got to hear the different speakers talk about agriculture in PA. They were told that no matter what you want to do, there is a job in Ag.

Speakers attending were Mark Critz from the state department of agriculture, Justin Clapper from PFB, PA State Senator Scott Hutchinson, and State Representative Donna Oberlander. They talked about the Animal Lab that will be created in western PA which will be funded in the budget. The budget also will address the shortage of veterinarians.

Two other guest speakers were Alex DiCicco and Sean Lauer, wardens from the PA Game Commission. They reviewed the rules and regulations for



farmers to help them kill deer for crop damage. There was quite a lot of discussion about the wildlife damage to crops.

### Bylaw changes that need to be brought to the attention of our membership before the Spring

Meeting. Full copies of our bylaws will be available at the meeting. The new bylaws need to be voted on by the membership to go into effect.

Article II Section 2- Remove Friends of Farm Bureau

Section 3- Application for Membership Upon special request, a member may select the affiliation to the county Farm Bureau of their choice. -Remove Section 6: Dues

b. Friends of Farm Bureau Member: Total dues\$100.00-Remove

Section 7: Membership in Good Standing: A member of this Farm Bureau shall be deemed in good standing if their membership is free from dues delinquency and not otherwise terminated, cancelled or in default on the date as to which the question of good standing is determined. - Remove

ADD:. For purposes of these bylaws, a "member in good standing" means a member who is current on their dues; has fully complied with any applicable policies and rules set by this Farm Bureau or Pennsylvania Farm bureau, including confidentiality and conflict of interest policies; and has not engaged in violent, belligerent, disruptive, or abusive activities such as: (1) violence, intimidation, threats, harassment, or physical or verbal abuse of directors, officers, employees, agents or members of this Farm Bureau; (2) causing or threatening damage to Farm Bureau property;(3)unauthorized use or access of Farm Bureau property; (4) knowingly disseminating incorrect, misleading, confidential or proprietary information regarding this Farm bureau; (5) any actions that may cause material risk or financial harm to this Farm Bureau.

The President may determine whether a member has potentially committed an offense to render them not in good standing and refer the matter to the Board for a final determination. The board may, in addition to any restrictions specifically mentioned in these bylaws, limit any services and privileges for any such member.

ADD. Section 8. Expulsion. A member who is not in good standing may be expelled by a 2/3 vote of a quorum of the Board if the Board believes that the member's transgression is serious enough, provided that notice and a hearing are given to the member. The notice shall include, with sufficient detail, the reason and relevant dates for potential expulsion. The Board shall issue and provide to the member a written decision with 30 days of the hearings.

#### Article III

Section 1. Number and Authority. (Change of Board members to include WLC and YAP from 9 to 11) ADD Section 2: Qualifications. . For purposes of this section, a "conflict" shall be deemed to exist where a person is employed by or serves as an independent contractor or agent with: (1) this Farm Bureau; (2) Pennsylvania Farm Bureau; (3) American Farm Bureau Federation; (4) any charitable foundation, subsidiary, or related organization of either Pennsylvania Farm Bureau or American Farm Bureau Federation; or (5) any company in a contractual relationship with this Farm Bureau or the Pennsylvania Farm Bureau where the contract is valued in excess of \$500,000 annually. Volunteer work for or on behalf of any of the previously listed entities shall not be deemed a conflict. For potential conflicts involving a contract valued under \$500,000, the PFB conflict of interest policy and related disclosures shall apply.

ADD Section 5. Quorum. A majority of the Board of Directors shall constitute a quorum.

**Section 6- Removal from Office** The following shall constitute sufficient grounds for the removal from office of any officer or director without the necessity of a vote of the Board of Directors:

ADD a. Death.

Article V

Remove Section4.2: Second Vice President: (Optional) The second Vice President shall, in the absence of the Vice President, exercise the powers and perform the duties of the Vice President; otherwise, the Second Vice President shall have such powers and perform such duties as may be assigned by the President or by the Board of Directors.
