PFB President Hoffman Discusses Top Priorities at Annual Meeting



Pennsylvania Farm Bureau (PFB) is urging lawmakers in Harrisburg and D.C. to address multiple key issues that will build resiliency in the agriculture community, Farm Bill, Dairy issues, Crop Damage, ACAP and more.

These priorities have been put at the forefront of PFB to aid in building a strong foundation for the agriculture community and our members. "Pennsylvania must prioritize the education and introduction of the younger generation to the field of farming. It is concerning to witness a decline in the number of young farmers, and we aim to address this issue with the assistance of the Farm Bureau and our constituents," Pennsylvania Farm Bureau President Chris Hoffman said during a news conference held as part of PFB's 73nd Annual Meeting.

"As we look towards the future, it is important to evaluate whether Pennsylvania farmers possess all the necessary tools and resources," Hoffman added. "It is crucial that we proactively tackle future challenges to ensure the resilience of our farmers and rural communities."

Hoffman noted that Pennsylvania Farm Bureau knows the importance of growth and success of rural Pennsylvania. To achieve this, the necessary infrastructure investments, including broadband, must be made.

Pennsylvania Farm Bureau also urged federal policymakers to ensure that agriculture is included in discussions about climate and sustainability, and to recognize the positive efforts already being made by farmers in these areas. Farmers are increasing food production while reducing inputs. But to enhance the farming industry, policymakers everywhere must maintain their support for agriculture, Hoffman said.

"We are working tirelessly to build relationships in Pennsylvania and around the country," Hoffman said. "With these relationships we can start looking forward to a bright future for agriculture not only in Pennsylvania, but across the nation."

Farm Bureau is urging Pennsylvania legislators to pass legislation that will help further develop and protect the future of agriculture. Establishing these connections will not only help this generation of farms, but the generation of farms that are yet to come.

Lastly, Pennsylvania Farm Bureau looks to state and federal lawmakers to work in a bipartisan manner to correct all issues facing agriculture today.

"We have the necessary resources – land, climate, and market accessibility," Hoffman said. "It is imperative that we make every effort to promote Pennsylvania as an exceptional farming destination."

Highlights from the 73rd Annual Meeting of PFB November 12-15, 2023 Hershey, PA

CVF was represented by Randy Hagofsky, Steve Reichard, Dave Yeany, Paul Stahlman and Bud Wills.



In two days, the delegates from all over Pennsylvania chapter reviewed and voted twice on 164 grassroots policies submitted from every county. Of the five policies which came from our CVF membership, only one made it through the voting. It reads "We oppose any restrictions on fossil fuels as a source of energy in agriculture, residential and commercial industries."

Our CVF Board reported that there was much more discussion this year on game commission issues than on dairy as it was in the past.

Elk County Farmer Honored with Distinguished Service to Agriculture

Award

Ernie Mattiuz was presented the Distinguished Service to Agriculture Award for his dedicated work and service for the advancement of PA agriculture. Ernie was a familiar face at our CVF meetings for eight years when he served as our representative on the PFB State Board.

Mattiuz, a third-generation farmer in Kersey, Pennsylvania, owns and operates Earleyville Farm, which he started as a cow-calf operation at the age of 18 with his father. As markets changed, Mattiuz decided to move into pork and began selling direct to the consumer, before transitioning into grains.

He is extremely passionate about educating the next generation of consumers, having spent years writing grants to help get the Pennsylvania Friends of Agriculture Foundation's Mobile Education Ag Science Labs into local schools.

"Ernie has shown true leadership in promoting the legislative needs of Farm Bureau and its members at the county and state level," PFB President Chris Hoffman said. "His efforts in Elk County have made an impact in educating the public about the needs of farmers, which is important for all of us."

PFB Members Elect Tommy

Nagle as Vice President

HERSHEY – Cambria County farmer Tommy Nagle has been re-elected as Vice President of Pennsylvania Farm Bureau (PFB) by voting delegates at the 73rd Annual Meeting of the state's largest farm organization.

Nagle previously was appointed as Vice President by the PFB Board of Directors to fill a vacancy following last year's Annual Meeting. "It was very humbling to be re-elected by the Farm Bureau members and delegates," PFB Vice President Tommy Nagle said. "President Hoffman and I will have a full agenda to promote and enhance the agenda of agriculture."

Nagle raises beef cattle and grows crops on his family farm in Patton, Cambria County.

Nagle served on the PFB State Board of Directors for three years before being elected Vice President. Nagle has served on the Cambria County Farm Bureau Board of Directors for eight years, from 2011-2019 and has served as the President of Cambria County Farm Bureau from 2014-19. Nagle has been a longtime contributor to Farm Bureau, previously serving as the Vice President of his county, and he served as the policy development chair and the Young Farmer and Rancher (now Young Ag Professionals) chair in Cambria County.

In 2013, Nagle and his wife, Tracy, won PFB's Young Farmer and Rancher Achievement Award, which is awarded to a Young Farmer and Rancher involved in production agriculture who has excelled in their farm or ranch and that demonstrate superior leadership skills. Nagle holds an accounting degree from Saint Francis University. Tommy and Tracy have five
