Submission Deadlines:

July 1 - Please submit this application to your County Women's Leadership Chair by July 1. If your county does not have a WLC Chair appointed, please submit the application to your County President. From there, the county should select ONE winner to forward on to the district level.

August 1 – Once your county has chosen a winner, please submit the signed winner's application to your District WLC Rep by August 1. Once the county entries are received, the WLC District Rep will have them judged to choose a district winner to be forwarded on to the state level. Once a district winner is chosen, the WLC District Rep may work with her to get her application to a good place for submission.

September 1 – Once the district winner is chosen, please submit the signed winner's application to the state office by September 1.
