Video

Theme: Grain Bin Safety

Eligibility: Ages 13-18 years old and <u>not</u> <u>limited</u> to children or grandchildren of Farm Bureau members but must be a Pennsylvania resident.

Winners: Will be announced in Grassroots Advocate, and displayed at Ag Progress Days, and PFB's Annual Meeting. Counties will select one winner from each age category of 13-15 years old and 16-18 years old. Entrants may only win one time in each category.

- First Place: Winner will receive a \$100 Visa gift card. Winner will also receive a ticket and one for parent/guardian to attend PFB's Annual Meeting.
- Second Place: Winner will receive a \$50 cash award.
- 1. One entry per person. Entries will be judged on the following:
 - Length: 30 60 seconds long
 - **Content**: Educational information based on the theme
 - **Date:** Must be taken within the last twelve months
 - **Quality:** Composition, clarity
