Annual Meeting Speakers



Tommy Nagle

Cambria County farmer Tommy Nagle was re-elected as Vice President of Pennsylvania Farm Bureau at the 2023 Annual Meeting in Harrisburg. Nagle raises beef cattle and grows crops on his family farm in Patton, Cambria County.

In 2013, Nagle and his wife, Tracy, won PFB's Young Farmer and Rancher Achievement Award, which is awarded to a Young Farmer and Rancher involved in production agriculture who has excelled in their farm or ranch and that demonstrate superior leadership skills. Overall, Nagle has more than a decade of experience in Farm Bureau leadership roles.

He served on the PFB State Board of Directors for three years before being elected Vice President. Nagle has served on the Cambria County Farm Bureau Board of Directors for eight years, from 2011-2019 and has served as the President of Cambria County Farm Bureau from 2014-19.

Nagle holds an accounting degree from Saint Francis University. Tommy and Tracy have five children.

She holds a BS degree in Environmental Biology from Clarion University. Her background in Ag includes being a herdsman for a 160

dairy cow operation.

Clarion County's GIS (Geographic Information System) does everything from maintaining data for 9-1-1 to making maps.

Clarion County GIS Department offers GIS consulting services, database management, custom maps, and training services to the county's departments and offices. Major priorities of the GIS Department include:

- Create, edit, and maintain current and additional GIS Layers
- Develop, manage, and maintain GIS database
- Performs GIS analysis for county agencies and public

- Developing custom maps
- Facilitating GIS education and training seminars

What is Clean and Green?

Clean and Green tax incentives were created in 1974 to encourage the protection of Pennsylvania's farmland, forestland and open spaces through lower tax assessments for land owners who enroll.

Property taxes for land enrolled in Clean and Green are based on land use values rather than fair market values, which usually results in a tax savings for landowners. In counties that have not had a recent countywide tax reassessment, taxes could already be lower on those properties.

Owners of 10 or more acres in eligible use may enroll. Properties of fewer than 10 acres can be enrolled if they can generate at least \$2000 annually in farm income.

In order to be eligible for Clean and Green, a property must fall into one of three categories:

- Agriculture use—currently in production agriculture.
- Agricultural reserve—lands are open space lands and must be open to the public for outdoor recreation or enjoyment of the land's scenic or natural beauty. The requirement for land being open to the public does not mean that the owner may not impose any restrictions on public access.
- Forest reserve—forested land capable of producing timber or wood products.

PFB Applauds Agriculture's Inclusion in 24-25 State Budget; Several PFB Priorities Signed into Law

CAMP HILL – Pennsylvania Farm Bureau is pleased that the 2024-25 state budget funds the creation of an animal health diagnostic lab in Western Pennsylvania, contributes \$50 million to the Clean Streams Fund, which extends the Agriculture Conservation Assistance Program (ACAP) and invests \$31 million to help farmers impacted by Highly Pathogenic Avian Influenza (HPAI). All three are key Pennsylvania Farm Bureau priorities.

PFB advocated for the need for an animal diagnostic lab in Western Pennsylvania to provide necessary testing for animals and helping speed up the results, allowing Pennsylvania to mitigate any infectious disease outbreak, like avian influenza, more effectively. Currently, the only diagnostic labs in Pennsylvania are located at Penn State, the University of Pennsylvania in Chester County and at the Pennsylvania Department of Agriculture office in Harrisburg. The site of the Western Pennsylvania lab has not yet been chosen.

PFB also advocated for the creation of ACAP in the 2022-23 budget and is pleased to see its continued funding. The program initially invested \$220 million for conservation programs across the state and PFB is pleased to see ACAP receive continued funding.

The budget allocated more than \$33 million in combined funding for Penn's School of Veterinary Medicine, also known as Penn Vet, and Penn Medicine's Division of Infectious Disease in 2024-25, despite the state withholding funding for the program last year. Funding for Penn Vet is crucial for agriculture, as it is the only-state funded veterinary school in the state.

Penn State ag research and Extension received flat funding at just under \$58 million.

Governor Josh Shapiro's 2024-25 budget also invests \$10 million in agriculture

innovation to help support new solutions and technologies including energy and conservation endeavors, funds the 2024-25 PA Farm Bill, funds Fresh Food Financing, PASS, and other food access initiatives.

Overall, the Department of Agriculture's budget grows nearly 10 percent to \$228 million, while general operations, centers of excellence and farmers market coupons will receive increased funding in the 2024-25 budget.

Pennsylvania Farm Bureau President Chris Hoffman shared the following thoughts on the 2024-25 state budget:

"Overall, this is a really strong budget for Pennsylvania agriculture," Hoffman said. "Once again, Governor Josh Shapiro and his administration has shown their commitment to agriculture by having a budget that reflects that. Investing in a new animal health diagnostic lab and investing in conservation ensures that the next generation of farmers have a place. Continuing to invest in agriculture is vital, as it creates food security for our state and our nation."
