## **Legislative Report Bob Rutledge**

Hello fellow Farm Bureau members!

Here is a brief rundown of the happenings legislatively at Farm Bureau. This year, I would like to highlight a few accomplishments of the past year at the state level.

Governor Wolf signed into law legislation that was adopted unanimously by the General Assembly creating a broadband authority in Pennsylvania. This authority is required to develop and oversee a plan for broadband deployment to rural areas. The hope is that under this authority's supervision, and coupled with federal infrastructure dollars, a significant improvement in service will be realized for rural PA. Another win for PA farmers was the signing of Senate Bill 725 that clarifies the type of driver's license those farmers can use while operating single trucks or truck combinations over 26,000 pounds. Farmers have always had an exemption from needing a CDL driver's license when operating those vehicles in PA. and 150 miles in interstate transportation. But enforcement actions by State Police were causing confusion as to whether farmers needed a Class A non- CDL, instead of a regular Class C driver's license. This Bill clarifies that farmers can use a Class A, B, or C driver's license in those circumstances.

Agritourism Civil Liability reform was made a reality in 2021 with the passing of Act 27. This Act will protect farmers operating agritourism businesses from frivolous lawsuits while operating their businesses. This is not a free pass to total negligence on behalf of the farmer but will provide legal protection for things that are beyond control of the operator such as uneven ground, unpredictable animals, or a bad storm. There are steps the farmer will need to take to qualify for this immunity, such as posting warning signs and providing visitors with a waiver to sign. Two tax code issues were addressed in 2021 as part of the tax code bill. First, Pennsylvania farmers will now be able to defer for one year income received from crop insurance for one year. Secondly, clarifying language was adopted on how farmers can qualify for sales tax exemption on multipurpose agricultural vehicles (such as ATVs and side-by sides). While farmers were already exempt from paying sales tax on these vehicles, they were often subjected to needless scrutiny and audits caused by internal rules of the Department of Revenue. The new language adopted by this bill should reduce the likelihood of future audits.

While the list of issues needing to be resolved to better our way of life in rural America never ends, I feel the accomplishments of Pennsylvania Farm Bureau this past year are commendable. Each of these legislative actions I listed above have real life effects on real life farmers. I would like to ask, if not for Farm Bureau, who would take up these issues with our lawmakers? Who would be your voice in Harrisburg? Who would lawmakers turn to for recommendations to remedy an ag related issue? Farm Bureau's grassroots policy development carries a lot of respect and weight among our legislators, and for that we should all be Farm Bureau Proud.
