Fuel Concern & Ocean Shipping Reform

Kyle Kotzmoyer, PFB State & Local Affairs Specialist is taking the lead on this issue. After discussions at the state level, it was determined that the supply of diesel is there, but terminals are hoarding it due to fears of a shortage. Therefore, suppliers are being turned away, which forces them to not accept new business. Additionally, by terminals holding back the diesel from suppliers, farmers are seeing rising costs since the price is being fabricated.

On a call with AFBF and other states' national affairs coordinators, no other states reported suppliers not having any diesel. Many others reported that supply is tight and prices are high, but PA was the first to raise concerns over suppliers not being able to get diesel from terminals. AFBF's transportation lobbyist, Andrew Walmsley, said that as long as panic-buying or another emergency does not occur, farmers "should" be okay. However, AFBF's economists are watching this issue closely for harvest season.

The Ocean Shipping Reform Act was signed into law on June 16! This was a huge victory for Farm Bureau as it has been a priority piece of legislation to combat supply chain issues. The Ocean Shipping Reform Act is supposed to reduce bottlenecks and increase the timeliness of ocean transportation. President Duvall was present at the signing ceremony where he expressed Farm Bureau's gratitude for the bipartisan efforts and efficiency in making this much needed legislation become a law. He commented that by working to solve the congestion at ports and establishing stricter standards for shipping companies, farmers have a more manageable way to get food to the table for families. The Ocean Shipping Reform Act gives the Federal Maritime Commission more investigate power to regulate ocean carrier practices. One way that the Ocean Shipping Reform Act assists supply chain problems is ocean carriers are not allowed to leave U.S. ports with empty containers now.

This third-generation, family owned, and operated farm is deeply rooted in tradition but embraces innovation as well.

Glenn Hope Care Farm, provides nutritious and flavorful food for York County and surrounding areas. Our produce, free-range eggs, poultry, pastured pork, and grass-fed beef yield consistently high-quality food for the local community. In addition to providing quality food, we also provide camaraderie for military veterans. Veterans face many challenges, but through our on -farm activities and community outreach we provide the support that is so needed.

Funding to Support PA Veteran Farmers

Pennsylvania Secretary of Agriculture Russell Redding announced that Veteran's services, agricultural and other organizations may apply for funding to deliver grants to military veterans for farm and related business start-ups and expansion.

The opportunity is available through the Pennsylvania Farm Bill and the Agriculture Business Development Center. The center will fund up to three \$100,000 grants to organizations which will in turn offer grants up to \$10,000 to individual military veterans for agricultural business needs.

The subgrants to veterans can support a wide range of expenses from food safety and biosecurity planning to equipment, marketing and working capital.

According to a recent U.S. Department of Agriculture Census of Agriculture, Pennsylvania is home to more than 7,000 military veterans who identified as agricultural producers.

"Pennsylvania agriculture needs a skilled, work-ready workforce to keep feeding the world," Redding said. "Veterans return from serving our country with valuable, transferrable skills they can put to work on the farm. Like any other business, they need to finance planning, safety, permits, equipment, and other critical needs. These grants are one way we can thank our veterans for their service and feed their future success in agriculture."

The PA Farm Bill increased support for the PA Preferred Homegrown By Heroes program, which helps farmer veterans market their locally grown products to feed consumer demand.

Farm Use Vehicle Guidelines

Farmers who own a farm vehicle may obtain either 1) a farm vehicle biennial exemption from registration ("farm sticker") or 2) a farm vehicle registration ("farm plate") for the vehicle. Each classification has different restrictions and allowances.

Liability Insurance must be maintained and the operator must have a valid driver's license.

Type A Exemption: Vehicles Eligible – Available to trucks and truck tractors with a gross vehicle weight rating of 10,000 pounds or less. Time of Operation - May only be operated during daytime. Authorized Use - May only be used: On roads that adjoin a farm owned or operated by the owner of vehicle; Between farms owned or operated by the vehicle owner not more than 50 miles apart; Between one farm of the vehicle owner and a place of business not more than 50 miles away for the purpose of buying agricultural supplies or selling agricultural products; and Between one farm of the vehicle owner and a place of business not more than 50 miles away for the purpose of servicing or repairing the farm vehicle or trailer or semitrailer towed by the farm vehicle. Biennial Fee for Exemption – \$26.

Type B Exemption: Vehicles Eligible – Available to trucks and truck tractors with a gross vehicle weight rating of greater than 10.000 pounds and not greater than 17,000 pounds. Time of Operation -May only be operated during daytime. Authorized Use - May only be used: On roads that adjoin a farm owned or operated by the owner of vehicle; Between farms owned or operated by the vehicle owner not more than 25 miles apart; Between one farm of the vehicle owner and a place of business not more than 25 miles away for the purpose of buying agricultural supplies or selling agricultural products; and - Between one farm of the vehicle owner and a place of business not more than 50 miles away for the purpose of servicing or repairing the farm vehicle or trailer or semitrailer towed by the farm vehicle. Biennial Fee for Exemption – \$26.

Type C Exemption: Vehicles Eligible – Available to trucks and truck tractors not subject to periodic inspection requirement with a gross vehicle weight rating, gross combination weight rating or actual gross weight of greater than 17,000 pounds. Time of Operation – May only be operated during daytime. Authorized Use – May only be used: On roads that adjoin a farm owned or operated by the owner of vehicle; - Between farms owned or operated by

Update on WOTUS

WOTUS (waters of the US) has been the subject of controversy and multiple Supreme Court decisions over the years. The challenge is how a WOTUS is defined, and how that definition impacts the ability of famers and landowners to use their land.

The Army & EPA recently held a roundtable discussion on June 6, 2022 organized by the Kansas Livestock Association. This roundtable is one of 10 accepted by the EPA and Army Corps. In addition to roundtables, NCBA has engaged on WOTUS by submitting technical comments on the Biden Administration's proposed phase one WOTUS rule and filing an amicus brief in the case Sackett v. EPA. NCBA has called for the EPA to pause WOTUS rulemaking until the case is decided.

On January 24, 2022, the Supreme Court announced they would grant cert in the high-profile CWA case, Sackett vs. EPA. A decision in this case could provide significant clarity on what is the proper test for determining which wetlands are "WOTUS" under the CWA (Clean Water Act). All eyes are on this case to see how it is ruled.
